It is our privilege and pleasure to support you as your USF Field Trainers. Part of our role and responsibility is working in close partnership with your supervisor to provide assistance in learning the many aspects of your job. This will occur once you have successfully completed the pre-service requirements and have been assigned a caseload. Here are some of the activities we can do together once you acquire a caseload:

- Assist in drafting family assessments, case plans and judicial review social study reports
- Assist in completing home studies, child studies, etc.
- Prepare for and attend case plan conferences/case staffings/family meetings
- Prepare for and attend court hearings
- Prepare for and complete adoption subsidy packets, consent packets, etc.
- Accompany you to your initial/subsequent home visit to the parents/caregivers
- Assist in preparing an ICPC/OTI packet
- Provide moral support, mentoring, coaching
- Review documentation for content and provide feedback
- Whatever you and your supervisor need for support, direction, etc....
